Conditions for recognition-

- ✓ The Institution will fully comply with all the conditions set by the Lal Bahadur Shastri Paramedical Skills and Training Council.
- ✓ The Institution will make available resources (land, building, lab equipment) etc. as per the standards of Lal Bahadur Shastri Paramedical Skills and Training Council, which can be checked by the Council at any time during the session.
- ✓ The Institution will follow the rules and examination bye-laws given by the Lal Bahadur Shastri Paramedical Skills and Training Council and the orders issued by the Council from time to time and only the fee determined by the fee determination committee will be collected from each student. Apart from the above, the orders of the Council issued from time to time regarding fees from the students will be effective, and it will be necessary to take action accordingly. If the fee for the current session is redetermined by the Fee Fixation Committee, the latest rates of fee will be applicable.
- ✓ Only students allotted by the Indian Paramedical Entrance Examination Council will be given admission in the Institution.
- ✓ The Institution will have to deposit inspection and recognition fees as per the orders of the Council issued from time to time.

- ✓ The Institute is bound to follow the laws/rules/acts/instructions issued by the Council and the rules, regulations, orders, directions made by the Director Lal Bahadur Shastri Paramedical Skills and Training Council.
- ✓ If the approval of the Institute is cancelled from the Council, then the entire responsibility in this regard will be of the Institute and the Institute itself will be legally responsible for any action.
- ✓ Compliance with the latest reservation rules issued from time to time for admission by the Government of India or the State Government will be mandatory.
- ✓ The Institution will have to provide a suitable environment for education and training and ensure all necessary arrangements to prevent ragging.
- ✓ During the surprise on-site inspection of the Institution, if the land, building, laboratory, equipment and other equipment are not found to be available in the Institution as per the standards of the Council, then the recognition of the institution will be terminated.
- ✓ The Institution will have to make available all the information about the institution on its website and council's portal, such as the historical background of the Institution, details of staff, equipment, equipment, fee to be received, hostel fee etc.
- ✓ No teacher mentioned in the list of working teachers given to the Institute Council before the commencement of the session can be removed from service during the session without the written permission of the Council.
- ✓ Along with verification of infrastructure facilities and employed teachers by the Inspection Committee, audit of the accounts of the Institute can also be done by the Council at any time.
- ✓ After the institution gets affiliation, if the information/details filled by the Institution at the time of online application, non-deposit of affiliation fee and any kind of error in the number of seats comes to the notice of the Council, then the temporary affiliation given to the institution will be cancelled. It will be automatically cancelled and the entire responsibility will be on the institute itself.
- ✓ If the post of Principal of the institution becomes vacant after the commencement of the session, then within three months from the date of vacancy, the selection process should be completed and appointment should be made to the vacant post, which must be informed to the Council.
- ✓ In case of non-compliance or violation of recognition conditions, disciplinary action will be taken as per rules.
