CIRCULAR

The term “Paramedical” has been historically used by the Council in its institutional titles, documents, communication, training manuals, certificates, affiliation letters, and examination-related records. However, **in view of the Circular issued by the National Commission for Allied and Healthcare Professions (NCAHP), Ministry of Health and Family Welfare, Government of India, dated 1st July 2025**, wherein the usage of the word “Paramedical” has been advised to be discontinued and replaced with the standard term “Allied and Healthcare”, the Council hereby adopts the following changes for ensuring compliance and uniformity:

1. Change of Council Name

In alignment with the NCAHP Act, 2021, and the above-mentioned Government Circular, the Council’s official name has been **revised and adopted** as:

“Lal Bahadur Shastri Health Sciences and Technical Council”

(Short Name: **LBSHSTC**)

(Old Name: *Lal Bahadur Shastri Paramedical Skill and Training Council*)

2. Implementation in All Official Records

All affiliated institutions, training centres, colleges, regional offices, coordinators and stakeholders are hereby instructed to:

- a) **Discontinue the use of the word “Paramedical”** in all forms of communication, including:
 - Official letters, notices and circulars
 - Advertisements, banners, websites, brochures
 - Institutional titles, prospectus and academic records
 - Examination documents, fee receipts, certificates, ID cards
 - Any other correspondence or documentation
- b) **Use the revised name “Lal Bahadur Shastri Health Sciences and Technical Council”** in all verbal, written, or digital usage with immediate effect.

3. Compliance by Affiliated Institutions

All affiliated institutions and centres are directed to update the following without delay:

- Nameboards and signages
- Websites and digital portals
- Social media profiles
- Student records and admission forms

- Affiliation certificates and renewal documents
- Training and academic material

A compliance report must be submitted to the Council within **30 days** of issuance of this Circular.
