


This is to inform you that, in accordance with the **Examination Bye-Laws, Course Structure and the approved Academic Calendar** for the Academic Session 2025–2026, all institutions affiliated to the Council and running **Allied Health Care (Paramedical) Diploma / Certificate programmes** are required to **mandatorily conduct** the following assessments:

- Mock Examination,
- Practical Examination,
- Viva-Voce Examination,
- Project / Field Work, and
- Internal Assessment.

As per the **Academic Calendar 2025–2026 approved by the Council**, the **Practical and Viva-Voce Examinations for the Academic Session 2025–26 shall be conducted from 05 January 2026 to 15 January 2026.**

Further, for the forthcoming examinations of the Academic Session 2025–26, the examination programme shall be conducted as prescribed hereunder.



Accordingly, it is hereby directed that:

1. All affiliated institutions shall ensure that all examinations are conducted strictly in accordance with the **courses, syllabus and assessment standards prescribed by the Council**.
2. Only those trainees/students whose names appear in the **online registered and approved student list (Approved Student List)** available on the Council's portal shall be permitted to appear in the examinations.
3. The **Internal Assessment** shall be conducted **only once**; therefore, institutions shall ensure that the **Internal Assessment marks of all eligible students are uploaded on the Council's portal within the prescribed time schedule**.
4. The Council may, wherever required, appoint **External Examiners / Observers**, and the concerned institutions shall extend **full cooperation** to them.
5. After completion of the examinations, all **practical answer sheets, assessment records, mark statements and project documents** shall be forwarded to the Council through the **prescribed mode within the stipulated time**.
6. In case of any **irregularity, delay, violation of rules, or inclusion of ineligible students in the examination**, the Council shall take **strict action as per rules**, and the **entire responsibility shall lie with the concerned institution**.

It is further directed that the **practical examinations shall be conducted strictly in Council-approved CCTV-enabled examination rooms**, and the **video recordings thereof shall be securely preserved at the institutional level**. After completion of the practical examinations, the **complete video recordings (CCTV footage)** shall be produced before the **authorised officer / observer of the Council**, as and when required, and shall be maintained in accordance with the directions issued by

the Council. Failure to comply with these instructions may result in the practical examination of the concerned institution being declared invalid by the Council.

In the event that, for any reason whatsoever, any student is deprived of appearing in the practical examination and approaches a Court of Law or any statutory Commission, the entire responsibility and liability shall rest with the Principal / Director of the concerned institution.


